The remaining 48 states and the District of Columbia use the same poverty guidelines. The extremely low-income limits therefore are first calculated as 30/50ths (60 percent) of the Section 8 very low-income limits. They are then compared to the appropriate poverty guideline and if the poverty guideline is higher, that value is chosen.

Low-income families are those that make less than 200 percent of the federal poverty guideline, \$21,780 for a single person or \$44,700 for a four-person household. Maryland Medicaid Children under the age of 18 who live in low-income families may qualify for Maryland's Medicaid Program.

Maryland had a small benefit increase in October 2012 and will have a larger increase effective November 2013. Maryland increased the TANF benefit by \$2 to \$576 for a family of three on October 1, 2012. Effective November 1, 2013, Maryland's benefit for a family of three will increase by \$48 a month, to \$624.

### **TANF Cash Benefits Continued To Lose Value in 2013 ...**

10.9% of Annapolis, MD residents had an income below the poverty level in 2017, which was 15.0% greater than the poverty level of 9.3% across the entire state of Maryland. Taking into account residents not living in families, 12.4% of high school graduates and 41.4% of non high school graduates live in poverty.
