Marriott measured the opportunity cost of capital for investments of similar risk using the Weighted Average Cost of Capital (WACC) as: $WACC = (1 - \tau) \cdot r_D \cdot (D/V) + r_E \cdot (E/V)$ where D and E are the market value of the debt and equity, respectively, r_D is the pretax cost of debt, r_E is the after-tax cost of equity, and V is the value of the firm.
